

**ORDINANCE NO. 07-2009**

**AN ORDINANCE OF THE MAYOR AND COMMITTEE OF  
TOWNSHIP OF HARRISON, COUNTY OF GLOUCESTER,  
STATE OF NEW JERSEY, AMENDING ORDINANCE NO. 16-2008  
OF THE CODE OF THE TOWNSHIP OF HARRISON**

**WHEREAS**, on April 21, 2008, the Mayor and Committee of the Township of Harrison adopted Ordinance No. 16-2008 creating a new Chapter 173 entitled "Planned Developments" of the Code of the Township of Harrison; and

**WHEREAS**, the Township's codification service, General Code, requested that the Township re-number Chapter 173 to Chapter 157 to maintain alphabetical consistency throughout the Township's Code; and

**WHEREAS**, the purpose of this Ordinance is solely to re-number Chapter 173 to Chapter 157.

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Committee of the Township of Harrison, in the County of Gloucester and State of New Jersey, and it is hereby enacted and ordained by the authority of same as follows:

**Section 1.**

Ordinance No. 16-2008 is amended to re-number "Planned Developments" to Chapter 157 of the Code of the Township of Harrison.

**Section 2.**

**Repealer.**

All prior Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

**Section 3.**

**Severability.**

Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

**Section 4.**

In all other respects, Ordinance 16-2008 shall remain in full force and effect.

**Section 5.**

**When effective.**

This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
