

**ORDINANCE 12 - 2009**

**AN ORDINANCE OF THE MAYOR AND COMMITTEE OF TOWNSHIP OF  
HARRISON, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY TO  
AMEND THE CODE OF THE TOWNSHIP OF HARRISON AND ADOPT A  
NEW ZONING MAP OF THE TOWNSHIP OF HARRISON**

**PURPOSE.** The purpose of this ordinance is to amend the Code of the Township of Harrison and adopt a new Zoning Map of the Township of Harrison.

**BE IT ORDAINED,** by the Township Committee of the Township of Harrison in the County of Gloucester, that an Ordinance known by the short title of “The Harrison Township Zoning Ordinance” shall be and is hereby amended and supplemented to provide as follows:

**SECTION I.** Article I Section 225-5 of the Code of the Township of Harrison is hereby amended to delete Chapter 225 Zoning, §225-5 Zoning Maps;

**SECTION II.** The Code of the Township of Harrison is hereby amended by adding thereto a new subsection to replace §225- 5 Zoning Maps to read as follows:

The Zoning Map of the Township of Harrison attached hereto and made a part hereof as prepared by Remington and Vernick, Base Map dated January 18, 2005 and last revised on January 29, 2009, and Zoning District Designations last revised November 17, 2008 to include Ordinances 51-2007, 58-2007, 59-2007, 32-2008, 37-2008, 38-2008 and 39-2008, is hereby adopted and shall continue to be known as the “Zoning Map of Harrison Township”. Said map and all notations, references and data shown thereon and all modifications, changes, supplements and amendments made thereto by former amending ordinances and by this Amending Ordinance are hereby incorporated herein by reference, and shall be as much a part of said Ordinance as if all were fully described herein.

**SECTION III. VALIDITY:** The provisions of this ordinance are declared to be severable, and if any section, subsection, sentence, clause or part thereof is, for any reason, held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of any remaining sections, subsections, sentences, clauses or part of this ordinance.

**SECTION IV. REPEALER:** All Ordinances or parts thereof, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

**SECTION V. ENACTMENT:** This Ordinance shall take effect immediately upon posting, publication, approval, filing with the Gloucester County Planning Board and publication in the manner prescribed by law.
